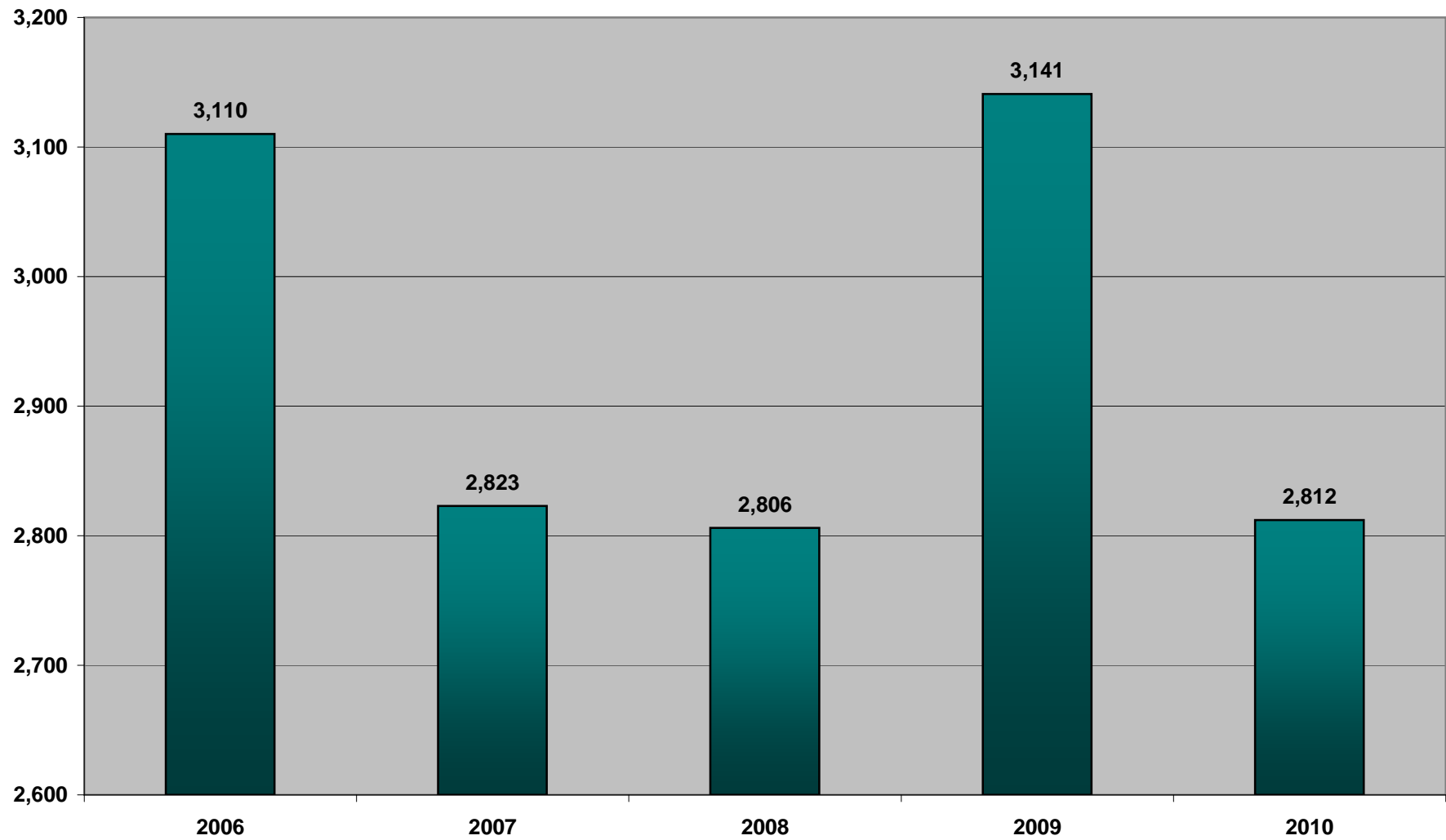

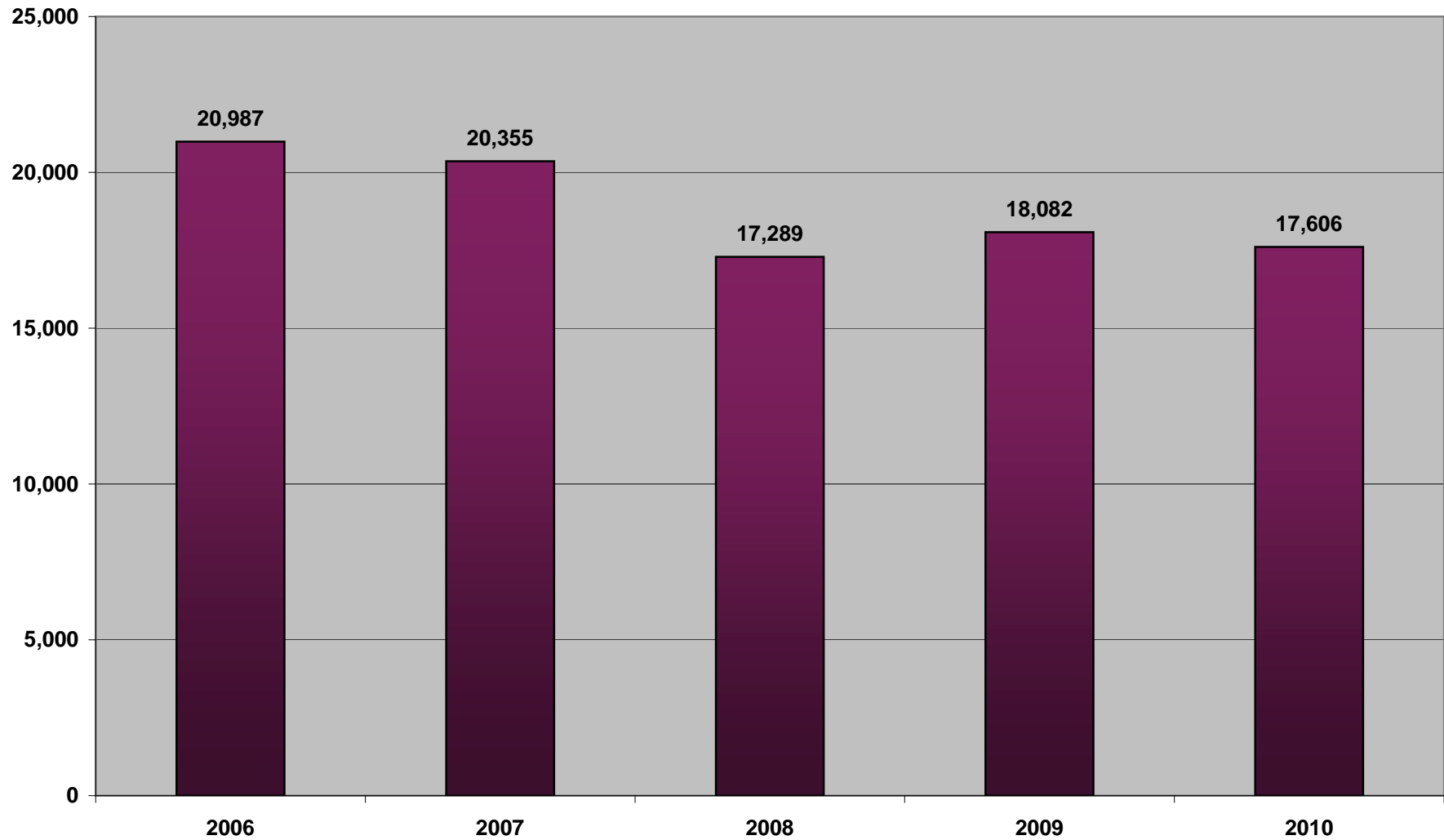

### Complaints 5 Year Comparison

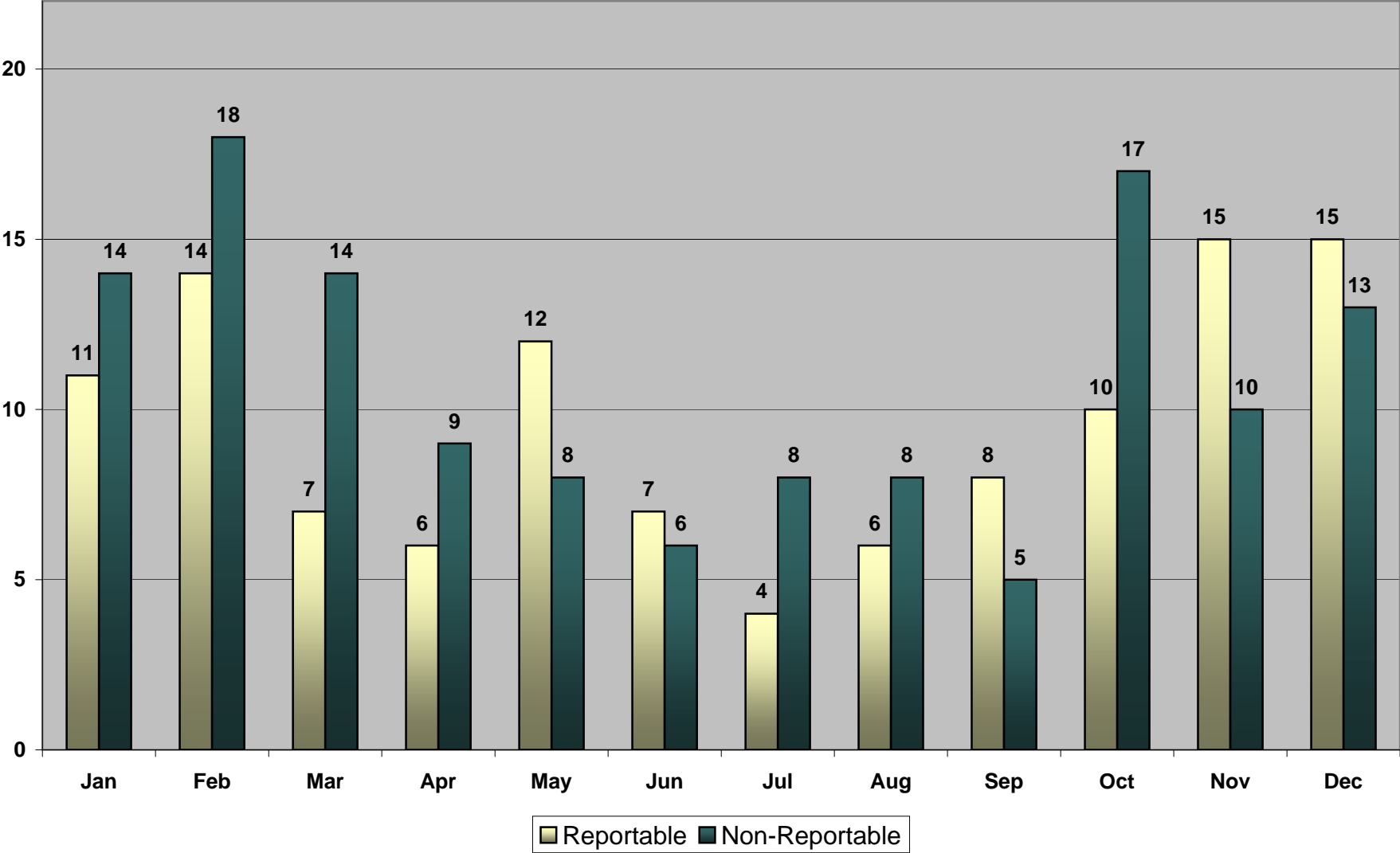

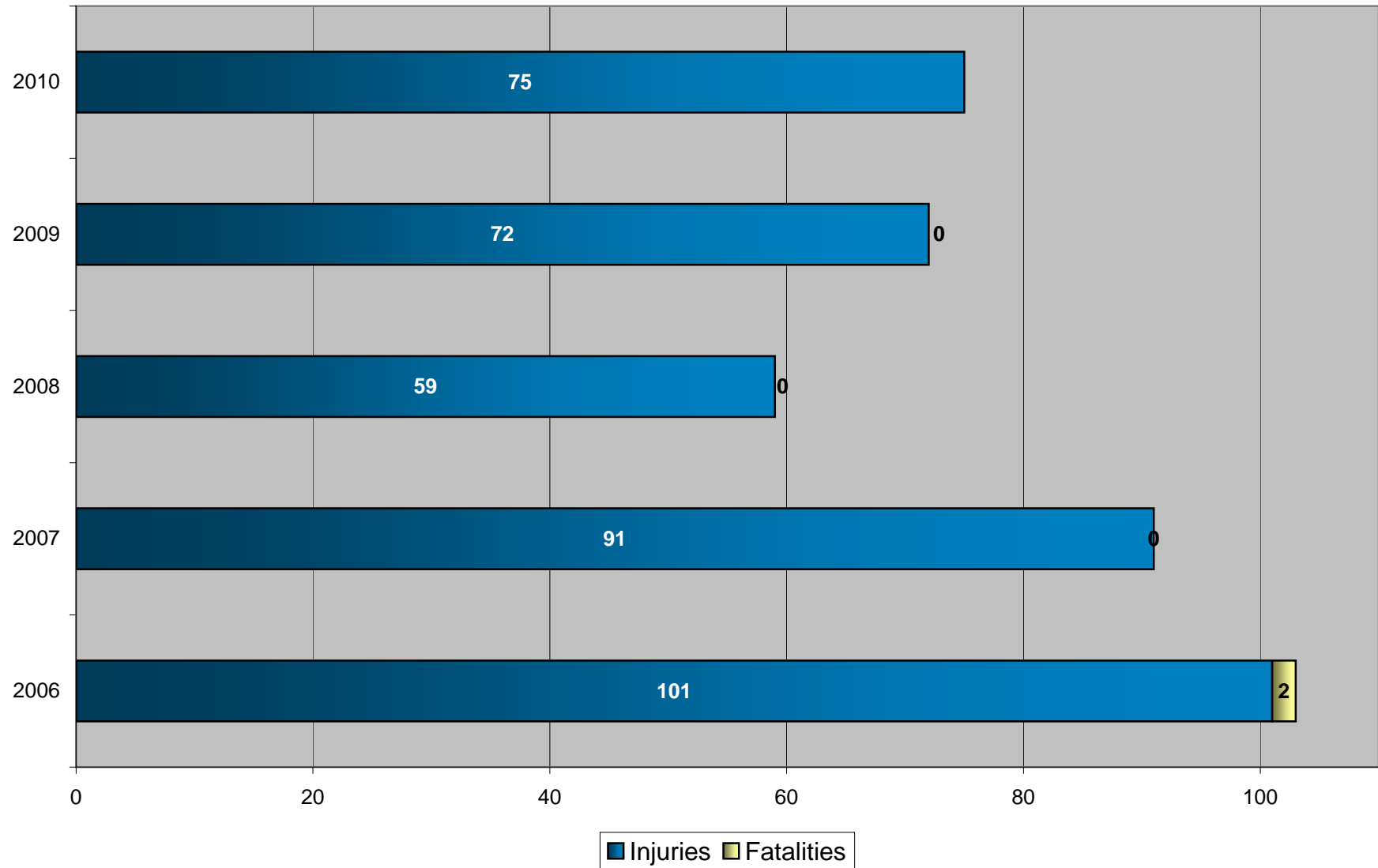




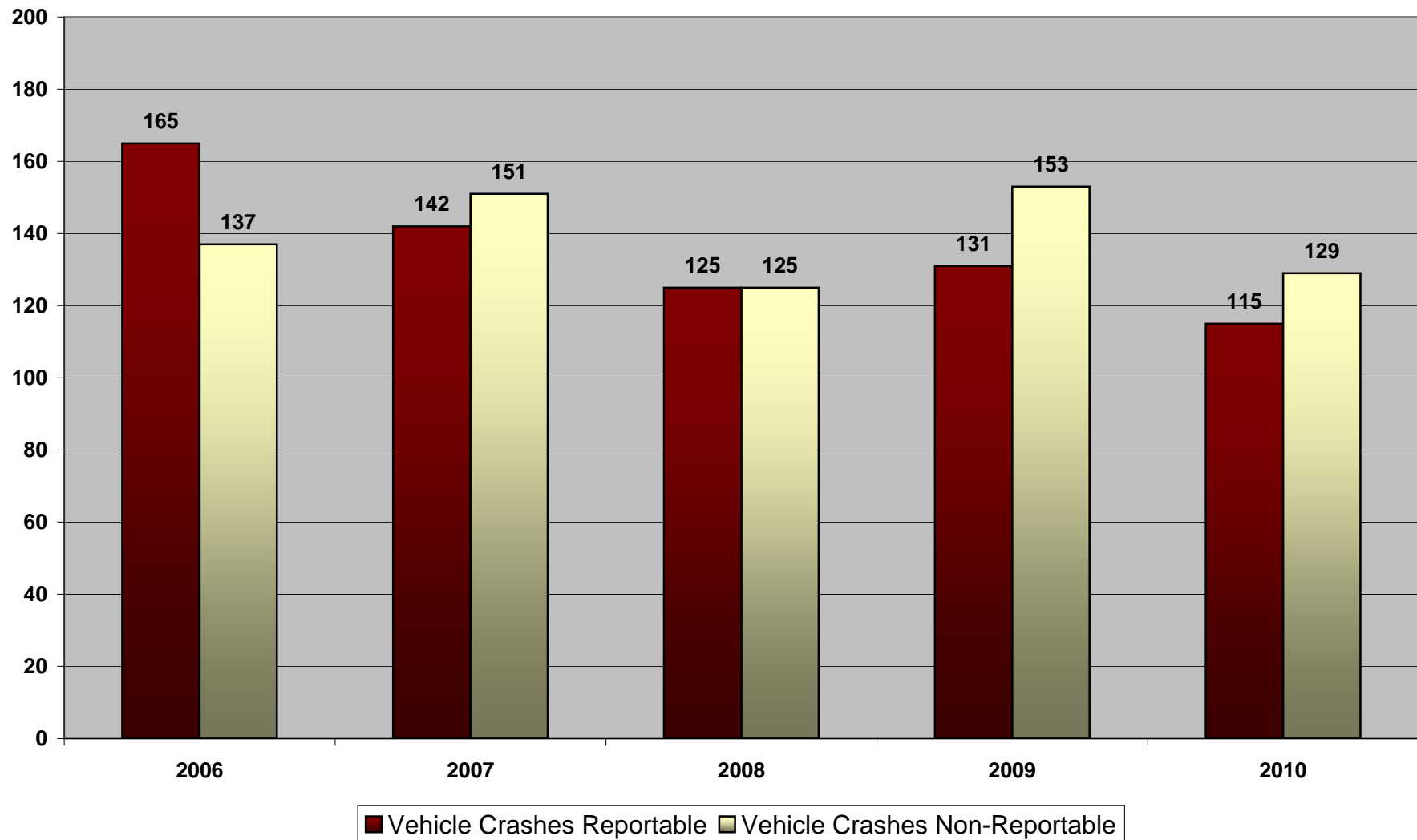
### Vehicle Crashes Comparisons by Month



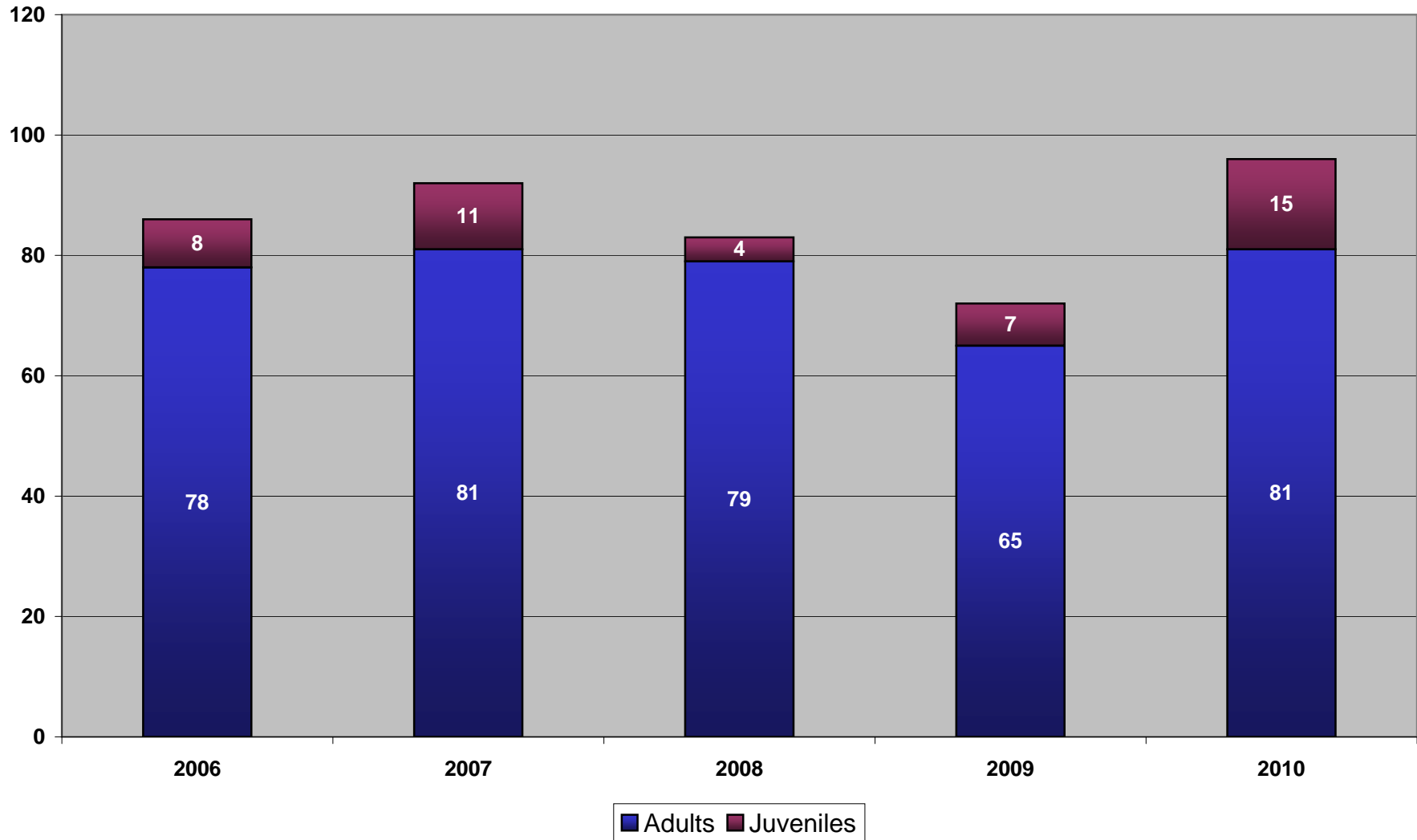
### Vehicle Crash Injuries & Fatalities 5 Year Comparison

**North Penn Area Driving Under The Influence Task Force**  
2010 Activity Report

The Franconia Township Police Department has been a member of the North Penn DUI Task Force since the inception of the unit. The team is made up of officers from the surrounding municipalities and is directed by Officer Thomas Starner from the Hatfield Township Police Department. The team is funded by grant monies from the PA DUI Association. The aim of the program is to present awareness and the dangers of DUI. The goal is to reduce the numbers of suspected impaired drivers on the highways in our area and across the state.

Officers from Franconia Township take part in the program by conducting roving patrols and standard checkpoint details. The following information is a breakdown of the details in which our department participated:

- Roving Patrols:
  - Eight details were conducted, each for a minimum time of four hours, during the late evening hours.
    - Driver Contacts - 100
    - DUI Arrests - 2
    - Traffic citations - 5
    - Warning notices - 50
  - A number of verbal warnings were also handed out to drivers. Two (2) of these details were “Free Roving Patrols”. The officers were not working on the grant; they conduct these as part of their routine traffic duties during their assigned shift. These patrol logs are submitted back to Officer Starner as part of our participation in the DUI Team.
- Standard Checkpoints:
  - On August 27, 2010 the officers from Franconia Township and other members from the North Penn DUI team conducted a standard checkpoint on Harleysville Pike near the Williams, Bergey and Koffel Funeral Home in the township.
    - Driver Contacts - 500+
    - DUI Arrests - 6
    - Signs of impairment but not arrested – 6 (These drivers were tested and had alcohol levels that were below .08%.)
- Training:
  - Each participating officer attended a four hour refresher and certification course on the set-up and implementation of the standard checkpoint. This is a requirement for the grant.
- Total of hours of Task Force participation by Franconia officers: 109

- Reimbursement:
  - Each municipality is reimbursed financially for the officers' participation. Franconia Township is expected to receive a total sum of \$7,586.79 in reimbursements from the DUI grant.

**North Penn Tactical Response Team**  
2010 Activity Report

- Training:
  - Team practices are held on the third Wednesday of each Month.
  - Practices are performed in a 12-hour day.
  - Practices consist of the following:
    - Building checks
    - Hostage situations
    - Barricaded subjects
    - Crowd control
    - Officer down & civilian rescue
    - Weapons qualification
    - Approaches to buildings and motor vehicles
    - Less Lethal qualification
    - Fitness agility
    - Stress course shooting
  - For additional training, an extended 3-day practice in October was held.
- Total training hours:
  - 144
- Callouts:
  - February 4<sup>th</sup>- Activated for barricaded subject in Franconia Township. The actor was taken into custody without further incident.
  - April 2<sup>nd</sup>- Activated for a “High Risk” warrant service in Lansdale Borough. Warrant service was successful and several actors were taken into custody and evidence was preserved.
  - May 5<sup>th</sup>- Activated for a barricaded subject in Upper Perk Police District. The actor was taken into custody without further incident.
  - May 15<sup>th</sup>- Activated for “High Risk” warrant in Souderton Borough. Warrant service was successful. Numerous subjects were taken into custody and evidence was preserved.
  - June 22<sup>nd</sup>- Activated for “High Risk” warrant service in Towamencin Township for two subjects involved in a violent home invasion in New York. Both subjects were taken into custody.
  - August 25<sup>th</sup>- Activated for armed barricaded subjects in Hatfield Township. Later it was determined to be a hoax.



- Activities:
  - September 20<sup>th</sup> thru September 24<sup>th</sup>: Officers Hinnershitz and Kranich attended the National Tactical Officers Association Conference in Pittsburgh, Pennsylvania. Officer Hinnershitz was awarded a scholarship by the Association.
    - During the 5-day conference, the officers attended various training sessions, including:
      - certification course in the use of the Less Lethal munitions
      - distraction devices
      - O.C. spray
      - Shooting through mediums designed for snipers.
      - Armored Vehicles and Shield Movements.
    - The Association and the North Penn Tactical Response Team provided the registration and lodging costs for the attendees.
  - November 6<sup>th</sup>: The entire team participated in the 4<sup>th</sup> annual: S.W.A.T. Challenge that was held at the Montgomery County Tactical Response Training Center in Conshohocken. The events included obstacle courses, hostage rescue (live fire exercise), low light shooting, and a sniper course. This year the team was awarded first place in the hostage rescue event. Overall, the team finished tied for third in the S.W.A.T. challenge.





## BACKGROUND

The Franconia Township Highway Safety Unit (HSU) was created in 2006. The officers who make up this unit specialize in the areas of traffic enforcement, motor carrier safety, and accident investigation/reconstruction. Along with the other members of the police department, the officers on the HSU strive to ensure safety on the township's roadways. For 2010, the Franconia Township Police Department had over 3,300 traffic-related public contacts.

## STATISTICS

### ENFORCEMENT

- **1,564** Traffic Citations were issued.
- **316** Faulty Equipment Notices were issued.
- **1,873** Verbal or Written Warnings were issued.

### OTHER STATISTICS

- Officers assisted **113** disabled motorists over the course of the year.
  - The JAMAR<sup>®</sup> traffic counter was not used during the year.
  - Officers removed **41** hazardous road obstructions from the roadways.
  - The speed display unit was utilized at **24** different locations in 2010.
  - Officers conducted **1,627** traffic enforcement details throughout the township.
  - **0** Child Safety Restraint checks were conducted.
  - **21** Roving DUI Details were conducted.
  - Officers assisted **59** motorists with vehicle lock-outs.
  - Traffic control was conducted **151** times in the township. This includes accident scenes, funerals, and special events/details.

## ACCIDENT INVESTIGATIONS

Officers responded to a total of **244** traffic accidents in 2010. Of those accidents:

- **115** were classified as **REPORTABLE** where at least one vehicle had to be towed and/or injuries were reported.

In 2010, **75** people were injured as a result of motor vehicle accidents in Franconia Township.

- **129** were classified as **NON-REPORTABLE** where no injuries were reported and no towing of vehicles was involved.

## MOTOR CARRIER VEHICLE SAFETY INSPECTIONS (MCSAP)



- In 2009, the Franconia Township Police Department became a member of the Montgomery-Bucks Motor Carrier Enforcement Team (MCET). This unit operates in both counties and is made up of specially trained officers from Hatfield Township, Montgomery Township, Cheltenham Township, Abington Township, Horsham Township, Warrington Township, Whitemarsh Township, and the U.S. Drug Enforcement Agency. Occasionally, officers from other jurisdictions also assist on truck details.

- For the entire year, the township's motor carrier officers conducted the following:
  - **88** Level 1 Inspections (Some of these inspections were conducted outside Franconia Township.)
  - **457** Violations were discovered.
  - **67** Vehicles or drivers were placed Out-Of-Service for major safety violations.
  - **22** Trucks were weighed.

## HIGHWAY SAFETY UNIT TRAINING

- Officer Albert Gesullo and Corporal Stephen Rinker attended MCSAP updates.
- Officer Steven Cronin completed extensive accident investigation training and became a Certified Accident Reconstructionist.
- Officer Travis Bivighouse attended a Collision Reconstruction Seminar at State College, PA. He also attended a class on Seat Belt Use and Occupant Kinematics.
- Officer James Throop attended training on vehicle equipment violations.

## HIGHLIGHTS OF DEPARTMENT ACTIVITIES FOR 2010

### **Certifications**

On June 14<sup>th</sup>, assessors from the Pennsylvania Chiefs of Police Association conducted an on-site review of the department's policies and procedures. As a result, the police department has achieved status as an Accredited Department for law enforcement agencies. The goal of attaining accredited status has been an on-going project in the police department for the last five years. All of the men and women of the department worked tirelessly to incorporate the policies and procedures into their everyday work environment. Of the 1,200 police departments in the Commonwealth, Franconia Township is the 70<sup>th</sup> department to achieve this recognition. .

### **Personnel**

The department welcomed its newest part-time officer, Peter Sandor, on February 23, 2010. Officer Sandor has several years of prior police experience working for police departments in Schuylkill County.

### **Enforcement Activities**

- On February 2<sup>nd</sup>, officers from the department responded to a report of an armed and barricaded subject on School House Road. The North Penn Tactical Response Team was activated to assist our officers. Unbeknownst to the officers, the male subject had left the house prior to the arrival of the police. However, the subject was taken into custody shortly thereafter when officers saw him in a nearby field.
- On Friday, August 28<sup>th</sup> the department conducted a DUI Sobriety Checkpoint on Harleysville Pike along with other members of the North Penn DUI Task Force. Six persons were charged with driving while under the influence.
- Officers from the department provided traffic control a numerous intersections in the township on Saturday, September 11, 2010 for the annual Univest Grand Prix cycle race.

## **School Resource Officer/Drug Abuse Resistance Education**

- School Resource Officer David Klepfer continued to be a presence on a regular basis at the Indian Crest Junior High School and the Souderton Area High School. He was able to intervene when problems with students arose as well as being an invaluable resource for personnel at the schools.
- Along with Sergeant Gower, he conducted emergency drills in all of the schools in the event of an intruder entering the buildings during school hours.
- Office Klepfer also conducted the Drug Abuse Resistance Education classes at the Vernfield Elementary, Franconia Elementary, and West Broad Street Elementary Schools. Over 200 fourth grade students received drug and alcohol use prevention training during a ten-week curriculum.

## **National Night Out Against Crime**

- The department hosted its fourteenth annual National Night Out celebration on August 3<sup>rd</sup>. The event was very well attended as new attractions were included this year. Our coordinator, Janice Froshour, did an outstanding job in organizing the activities and those who helped to make the evening a success.
- In November, the Police Department was selected by the National Association of Town Watch as a National Award Winner for our National Night Out Against Crime celebration. This is the second year in a row the department received this national award.

## **Community Activities**

- The managers and associates from the Harleysville Wal-mart store presented a check for \$1,000 to the police department from a company grant program. Chief Kozeniewski and Sgt. Jeff Gower accepted the check at the store staff meeting on January 29th
- Corporal Steve Rinker attended the first sessions of the Community Leadership Institute that is sponsored by the Indian Valley Chamber of Commerce.
- Officers assisted the members of the Franconia Mennonite Church with their Fall Festival in October.

## **Training**

- On January 19<sup>th</sup>, Cpl. Stephen Rinker, Officer Steven Cronin, and Officer Chris Hinnershitz attended the Street Survival Training Course in Atlantic City, NJ.
- Chief Kozeniewski attended the Mid-Atlantic Law Enforcement Executive Development Seminar that was held at Princeton University in New Jersey during the first week of June.
- Officer Glenn Kranich conducted re-certification training during the month for all department officers in the use of the Taser device.
- All department members received their certification training in First Aid and CPR during August.
- All sworn members of the department completed their annual in-service update classes during the year. The sixteen hours of instruction focuses on new laws, current court rulings, and officer safety tactics. The training is mandated by the Municipal Police Officers Education and Training Commission.
- Detective George Moyer attended the annual conference of the Pennsylvania Juvenile Officers Association. He is a member of their executive board.
- All of the department's officers had their transition training for the Glock handguns. All officers qualified at the range with their weapons.
- Officers Tim Boyle and Wayne Pursell attended training for the Montgomery County Major Incident Response Team.
- Officers Glenn Kranich and Chris Hinnershitz continued with their regular training as members of the North Penn Tactical Response Team.
- Officer Steve Cronin attended training and received his certification as an Accident Reconstruction Specialist.

## **Commendations**

Several officers were recognized for their accomplishments during the year. Commendations were presented at the department dinner in December. The following officers were honored:

### **Unit Citation**

On February 2, 2010, officers were dispatched to a report of a barricaded subject in a home after he had threatened a female with a gun. The subject was taken into custody a short time later. Each of the officers had provided assistance in some manner during the episode and afterwards.


