Open House Planned for Intersection Realignment

n Monday, October 24th, 2011 from 6PM to 8PM at West Broad Elementary School, the Pennsylvania Department of Transportation (PennDot) will host a public open house to discuss the proposed realignment of the intersection located at W. Broad / Cowpath / Godshall roads.

As many may recall planning for this project originally began back in 2002. Since that time PennDot has taken over the full design and construction of the proposed intersection improvements which include the removal of the existing box culvert crossing and the installation of a free-span bridge and signalization of the new alignment.

At their regular meeting held Monday, September 19th, 2011, the Board of Supervisors agreed to the revised intersection design by approving a motion authorizing the Township to formally submit a concurrence letter on their behalf. The new plan addressed the numerous issues raised by the board when they saw the previous plans such as the length of the left turn lanes, cross slopes of the roads and drainage concerns. Additional alignment changes were also made to the design which will impact certain property owners. PennDot tentatively plans to let contracts for the project in the summer of 2012 with construction beginning in the fall of 2012. Funding is in place through 2012-2013 for the project.

Snow and Ice Removal

inter is coming and with winter comes the chore of snow and ice removal! In spite of the many groans that ensue with the mention of the words snow removal, it is a necessary evil. It is the responsibility of all owners, tenants or occupants of occupied or unoccupied properties to remove snow and ice from the sidewalks surrounding the property within 30 hours after the snow or sleet has ceased to fall. A pathway must be cleared in the sidewalk in the event of snow. The sidewalk must be covered with cinders, sawdust or similar snow and ice control materials in the event of ice and sleet. The pathway should not be less than 30 inches wide and it should be thoroughly cleared of snow or ice. The snow and ice may be piled on the curbside of the sidewalk, but it should not be piled in the gutter or cartway. Do not shovel your snow into the streets because when the plow goes by it will go back into your driveway. The quick removal of snow from the sidewalks will help eliminate the safety hazards ice and snow can create.

HOUSEHOLD HAZARDOUS WASTE & ELECTRONICS COLLECTION PROGRAM ACCEPTABLE ITEMS

Paint Products:

Oil-based paint, paint thinner, turpentine, shellac, stains and varnish, furniture stripper and finisher and wallpaper cement.

Outdoor Products:

Swimming pool chemicals, weed killers, septic tank degreasers, asphalt sealers, caulking compounds, joint compound, roof cement and rodent poison.

Automotive Products:

Grease and rust solvents, fuel additives, motor oil, antifreeze, gasoline, carburetor cleaners, transmission/brake fluid, and lead acid batteries.

Household Products:

Drain/oven cleaners, rug cleaners, kerosene, toilet bowl cleaners, adhesives/solvents, mothballs/flakes, spot removers, dry cleaning fluid and wood and metal cleaners.

Electronic Equipment:

CRT Monitors, CPU's, cameras, cell phones, fax machines, scanners/printers, televisions (30 inches and smaller), and computer peripherals.

Miscellaneous:

Acids, caustics, solvents, flammables, oxidizers, organic peroxide, reactives, lead, pesticides, mercury bearing items, propane cylinders (20lb or less) and rechargeable batteries.

*This program is a community service to the residents of Montgomery County and Bucks, Chester, Delaware and Philadelphia Counties ONLY and is NOT open to businesses, institutions or industry.

WHAT AND HOW TO RECYCLE FOR CURBSIDE COLLECTION

Aluminum, Steel & Bimetal Cans: All metal food, beverage and aerosol cans are recyclable. All other metal items such as pots and pans, wire hangers are not recyclable. No lids or covers, just cans. Rinse out and crush aluminum cans if possible.

Glass - Clear, Amber and Green Glass: All glass food, beverage bottles and jars are recyclable. No lids or covers.

Plastics Number 1 & 2 (HDPE & PETE): Look for the number in the triangle on the bottom of plastic items. No lids, rinse out containers.

Newspapers, Magazines & Junk Mail:

Tie in a bundle or place in a paper bag. (Not in Plastic Bags).

Stormwater & You Too!

n this issue of FrancTalk we can report that progress appears to be happening in the development of new Stormwater Management Rules that Franconia Township and our neighboring municipalities will be required to abide by in the not too distant future. Previously we spoke of the development of these new rules, how they need to be published in the PA Bulletin to become enforceable and how they may dramatically change the way Franconia, and its resident and business communities, use their properties. The driving force behind the new rules is a Federal Mandate to increase regulation under new interpretations of Stormwater Regulation by the Clean Water Act with the Chesapeake Bay Watershed Presidential Executive Order the initiative to implement more aggressive approaches.

The Pennsylvania Department of Environmental Protection is empowered to issue permits for the Federal Government under the Clean Water Act with the Environmental Protection Agency overseeing and approving the language and administration of the permits. Currently Franconia, as most local governments, is in the 8th year of their original Stormwater Permit issued by DEP as a General Permit, PAG-13. A General Permit is one where the permit holder agrees to follow a 'protocol', that is a formula of enforcement and activities outlined in the

Pennsylvania Bulletin, with the filing of annual reports to demonstrate compliance with the rules. Up to now, the main part of the program has centered on a 'Narrative' basis, which is essentially a series of activities, known as the Six Minimum Measures, which are described in detail on the DEP and EPA Websites.

What we now anticipate is that by the time of you reading this, the 'Final' new Stormwater PAG-13 rules will either have been formally published or will be expected shortly. Following the publication, DEP will begin training programs across the Commonwealth where municipal managers, Stormwater MS4 Administrators and Municipal Engineers will be trained on how to implement the new rules. We expect them to include more controls over the Land Development process, increased oversight of grading permits including building additions and new impervious pavements as well as increased record keeping and reporting.

Of particular concern will be the requirement of the Township, and surrounding MS4 Permit Holders, to develop Stormwater plans to reduce existing sediment and nutrient concentrations in the runoff entering the Township's Indian Creek, Neshaminy and Skippack Creek Watersheds. These plans, required under the updated PAG-13 and other Stormwater Permits for Industries and Concentrated Animal Feeding Operations, are specific
