Board of Supervisors Hire Planning Consultant for IVRPC

In November 2004, the BOS approved the hiring of a professional land planner, Joseph A. Zadlo, to assist the township to revise its zoning and mapping to comply with the Indian Valley Regional Planning Commission (IVRPC) recommendations that are planned to be implemented during 2005.

A Zoning Ordinance Committee was appointed on January 3, 2005 to review the proposed IVRPC land use and mapping recommendations and to draft zoning changes and definitions that will be reviewed by the Planning Commission, BOS and the public. The BOS will have two years to bring the township zoning ordinances into compliance with the IVRPC once the Implementation Agreement is executed.

Public hearings are expected to begin in May 2005 regarding the proposed IVRPC land use and mapping recommendations. A draft of the plan is available for public inspection during normal business hours (8:00AM to 4:30PM) at the township offices.

What's New With the Park & Recreation Board?

he park and recreation board have a few projects planned for 2005. They are currently looking to place signs at the Franconia Community Park at both the Allentown and Godshall Road entrances. The signs will contain a message board where the committee will be able to advertise township park events such as the Mango Men Concert. The signs will also allow them to get the information out when events have been canceled due to inclement weather. The board is currently reviewing cost estimates and designs for the park signs. In addition to park signs, public restrooms are also being reviewed. The board would like to construct a public restroom at the Franconia Community Park. The restroom would be located in close proximity to the athletic fields closer to the Godshall Road side of the park. Designs are not yet completed but have been discussed.

The board has been investigating ideas to improve the pond located at Enos Godshall Park. Currently the pond is covered with algae and duckweed. A township resident, Brianna Worley, studied the pond while doing a project for a class she was enrolled in at Ursinus College. Ms. Worley presented a proposal to create a wetland within the pond to the Franconia Park and Recreation board, Public Works Director, and the Franconia Township Board of Supervisors who were all in favor of the proposed idea. The park and recreation board has agreed to take the proposal Ms. Worley had prepared and pursue the project. Currently information is being gathered on the different permits that may be required for a wetland transformation.

In October of 2004 the park and recreation board applied for a grant to

Open Space Efforts Showing Success

he Board of Supervisors continue to realize success in the their effort to preserve some of Franconia Township's farming heritage. In 2004 the township participated in funding to permanently preserve the Nice farm located along Harleysville Pike (113) between Meetinghouse and Moyer roads. Additionally, the township secured the 57-acre Moyer farm at the corner of Halteman and Moyer roads. Currently the township has secured approximately 530 acres of farmland with another 110 acres in the process of negotiations or settlement. Upon settlement of these farms the township will have successfully preserved nearly 640 acres of farmland that will not be available for future development.

2005 Open Space and Environmental Resource Plan

he Open Space Committee plans to submit its revision of the Open Space and Environmental Resource Plan to the Board of Supervisors (BOS) in April 2005. Once received by the BOS, a public hearing and review of the plan will be conducted. Approval of the plan is expected by June 2005 and it will then be submitted to the Montgomery County Planning Commission for their review and approval. The plan revision meets the requirements of the Montgomery County Open Space funding and will be key to assisting the township in securing additional open space grant funding through the recently approved Growing Greener referendum approved by Montgomery County residents. The township expects to be eligible for nearly \$1.2 million in grant funding during the first round of funding.

Cemember that taking the time to recycle helps to improve the land, air, water, and finances of Franconia Township. Simply sort plastics, aluminum, glass, and bi-metallic cans and place in a recycling bin. Newsprint and other paper must be bagged separately. Make sure the cans and bottles are washed out and the lids have been removed and discarded in the regular trash. Then place the recyclables out on the curb for your private waste hauler to pick up on trash day. Free recycle bins are available at the Township Office located on Allentown Road. Additional recyclables can be dropped off at the Public Works Building located at 480 Indian Creek Road. There is one dumpster for glass (clear, brown, and green) and a second dumpster for aluminum cans only. Cardboard may be placed in a third dumpster. Please open and flatten boxes before placing in dumpster. Paper and plastic cannot be recycled at the Public Works Building. develop the first phase of Forrest Meadow Park through the Pennsylvania Department of Conservation and Natural Resources (DCNR) Community Conservation Partnerships Program. The program provides state and federal grant dollars to help fund community recreation projects like Forrest Meadow Park. A number of interested partners contacted the township and were included on the grant application. The application was completed and submitted by the Assistant Township Manager, Jamie Brophy on October 12th, 2004. The board is currently awaiting the results of the application process to see if the project was selected for funding. Results are due back by March 31, 2005.

Aside from projects the board is also busy with the yearly park items. Applications are being accepted until February 28, 2005 for use of the township fields. Pavilion reservations are also being accepted at the township building. Applications can be picked up and filled out Monday through Friday from 8:00AM until 4:30PM. With the summer season quickly approaching the board would like to let everyone know that they will be offering discount amusement park tickets this summer. The park and recreation board continue to plan events for township residents. Please reference the events schedule of the newsletter to find any upcoming events through the park and recreation board.

Act 537 Plan and Sewer Management Program Approved

he Department of Environmental Protection (DEP) granted final approval of the Franconia Township Act 537 Plan on December 14, 2004. A major component of the plan is a Sewer Management Program (SMP) that will require inspections of all existing on-lot disposal systems (OLDS). The SMP has divided the township into four areas based on watersheds. Each area will take approximately 9 to 12 months to complete inspections and submit its results to the BOS who will be charged with determining the options for correcting and/or eliminating any failing systems along with DEP support.

West Broad/Cowpath/Godshall Roads Intersection Realignment

Dince 2002 a steering committee has been planning a proposed realignment of the intersection located at W. Broad / Cowpath / Godshall roads. In 2003 a consultant was hired to conduct environmental studies, propose designs, and prepare for construction at the intersection. The project is assigned to the Commonwealth's Transportation Improvement Plan (TIP) that supports highway projects through local, state and federal funding.

In April 2004, the township held an open house to introduce the project to residents. Currently the project is completing its first phase of work. Preliminary TS&L (type, size & location) plans were submitted to PennDot in December 2004 and will be reviewed once the hydraulic report and bridge calculations are submitted. On January 21, 2005 the project received cultural resource clearance from PennDot. Preliminary plan approval is expected sometime in mid 2005.

The SMP is expected to begin in April 2005, weather permitting, in the Morwood and Earlington areas. An open-house educational seminar was conducted in May 2004 to explain the then pending and now approved SMP process. Nearly 350 residents from the Morwood and Earlington areas attended the seminar. Surveys should be mailed during March 2005 along with additional educational material further explaining the SMP and the responsibilities of those residents that have OLDS on their property. Additional educational seminars will be held in each of the remaining watershed areas prior to commencement of inspections in each of those areas (one seminar per year).

Schoor DePalma Engineers will serve, as the township Sewage Enforcement Officer (SEO) during the study will manage the SMP. Efforts will be made to educate property owners, that have on-lot sewage disposal systems (OLDS), how to maintain these systems and explore options to correct existing OLDS that may be malfunctioning. A section of the township website (www.franconiatownship.org) will provide information regarding the SMP, educational material and links and points of contacts for any questions regarding the SMP.

"Help Us Manage Stormwater **Pollution**"

Dtormwater Ordinance Status: Franconia Township Engineers are currently working on a new stormwater ordinance. In March the engineers are hoping to present the ordinance to both the Planning Commission and the Board of Supervisors at their regular work session. The ordinance will be presented in draft form to the board and then advertised for a public hearing at a regular meeting of the board of supervisors. At this meeting residents will be able to comment on the ordinance. We expect the public hearings to be held sometime this spring.

WHAT IS STORM WATER?

When it rains or snows, all of that precipitation either travels over the land or seeps into the ground. The water that runs over the land and gets into the storm sewer system is called storm water runoff. This water then goes directly into our nearby creeks, rivers, and lakes.

WHAT'S THE PROBLEM?

As this water flows over the ground and through the streets it washes debris, chemicals, and other pollutants into our creeks. The runoff, along with everything it collects on the way, never gets treated! It requires very expensive treatment technologies to remove these harmful pollutants from our drinking water supplies. In addition, excessive debris can clog inlets causing flooding and property damage.

WAYS FOR YOU TO PREVENT **STORMWATER POLLUTION:**

- Properly dispose of hazardous substances such as oil, cleaning supplies, and paint. Never pour them into the storm sewer system.
- Properly and efficiently use pesticides, fertilizers, and herbicides to prevent excess amounts into runoff.
- Report any signs of soil or other debris washing out of construction sites that could impact water quality.
- Pick up after pets and dispose of their wastes in the toilet or trashcan.
- Install innovative storm water practices on residential property such as rain barrels or rain gardens.
- Report any discharges from storm system outfalls during times of dry weather- a sign that there could be a problem with the system.
