APPROVAL OF SEPTEMBER 17, 2018 REGULAR MEETING MINUTES

Supervisor Nice made a motion to approve the minutes from the September 17th, 2018 Regular Meeting. Supervisor Fazio seconded the motion. The motion passed.

SOLICITOR 'S REPORT - ERIC WERT., ESQUIRE

Mr. Wert announced that Ordinance 400 as it appears on the agenda, has been advertised and submitted to the Montgomery County Planning Commission. The draft Ordinance is being revised and will be heard at the next regular meeting scheduled for November 19, 2018.

POLICE REPORT- CHIEF MICHAEL MARTIN

Chief Martin submitted his report. He made a correction to his report that the training for the new records management system occurred at the Police Department here in Franconia not at the county facility. He addressed the mud on the roadways and how the contractors were contacted and all operations were shut down for the day. The causes were due to a swale that

developed following the rain and it will be fixed. Additionally, there will be no hauling tomorrow and the fact that they were down to only one street sweeper operational today added to the issues. Chief Martin will be continuing to monitor the project.

HIGHWAY REPORT-PAUL R. NICE

Mr. Nice submitted his report and noted that the weather has made it very difficult to get wearing courses done this month.

Chairman Godshall and the Board thanked the Indian Crest Middle School students that aided in the staining of the gazebo and picnic table at Chestnut Grove Park.

ENGINEERING REPORT- DOUGLAS C. ROSSINO, P.E.

Mr. Rossino submitted his report and informed the Board that The Vistas at Highland Ridge has been issued a final site punch list and Hopewell Christian Fellowship has had their final construction security released. Lincoln Woods continues to develop various residential lots.

TREASURER'S REPORT -

A motion was made by Mr. Nice and seconded by Mr. Fazio to approve the Treasurer's Report as presented, and to provide authorization for the Treasurer to pay all bills for the respective funds as presented on Voucher No. 18-15-10 dated October 15, 2018 in the amount of \$626,291.34. He explained that there was \$92,000 paid to the Fire Associations, \$170,000 from liquid fuels for the chip and paving projects and \$159,000 to the pension funds. The motion carried unanimously.
