A motion was made by Mr. Godshall and seconded by Mr. Kratz to approve the November 19, 2012 Regular Meeting Minutes. The motion carried.

# SOLICITOR'S REPORT – JOSEPH C. KUHLS, ESQUIRE

- 1. A motion was made by Mr. Barndt and seconded by Mr. Godshall to adopt Ordinance 374 An Ordinance authorizing the Incurring of Debt; Describing the Project for Which the Debt is to be Incurred; Stating the Maximum Aggregate Principal Amount of the Franconia Sewer Authority Guaranteed Sewer Revenue Bonds, Series of 2012 ("Bonds") to be Secured by A Guaranty Agreement Between the Township and the Franconia Sewer Authority. At 7:02 p.m., a public hearing was conducted prior to the motion to introduce the bond documents and seek public comment. No comments were received. The hearing was closed at 7:05 p.m. The motion carried.

- 3. A motion was made by Mr. Barndt and seconded by Mr. Kratz to approve Resolution No. 12-22-10-12 for the Approval of the 2013 Budget Documents. The motion carried.
- 4. A motion was made by Mr. Barndt and seconded by Mr. Kratz to approve Resolution No. 12-23-10-12 Assessing a 2% Discount to Taxpayers Making a Payment of Total Amount Thereof Within Two (2) Months after the Date of the Tax Notice; and Assessing a 10% Penalty to Taxpayers Making Payment of Total Thereof Four (4) Months after the Date of the Tax Notice; and Establishing an Interest Rate of 10% on Municipal Claims for Delinquent Taxes. - 10. A motion was made by Mr. Kratz and seconded by Mr. Freed to authorize the Township Treasurer to prepare and issue an Agricultural Conservation Easement Payment in the amount of \$158,243.61 for the Halteman Farm consisting of approximately 50+/- Acres (Allentown Road). The motion carried.

A motion was made by Mr. Kratz and seconded by Mr. Godshall to authorize the appropriate Township Officials to execute an Offer Agreement for the Landis Farm consisting of approximately 35+/- Acres (Morwood Road) and the Yoder Farm consisting of approximately 24.5+/- Acres (Orchard Lane).
