REGULAR MINUTES BOARD OF SUPERVISORS

Chairman Grey Godshall called the Regular Meeting of the Board of Supervisors to order on Monday, June 20th, 2016 at 7:00 p.m. at the Municipal Building, 671 Allentown Road, Telford, Pennsylvania 18969.

Present were Chairman Grey Godshall, Vice Chairman David Fazio, Supervisor Robert Nice, Supervisor Curtis N. Kratz, and Supervisor Steven P. Barndt. Also in attendance were Township Manager Jon A. Hammer, Chief of Police Joseph Kozeniewski, Township Solicitor Frank Bartle, Esquire, Township Engineer Douglas Rossino P.E, and interested residents of Franconia Township.

OPEN MEETING TO THE PUBLIC

Chairman Godshall opened the meeting to the public. Mr. Jerry Thiel raised concerns about the trash and recycling that the township offers at the public works garage located on Indian Creek Road. He stated that it is often overflowing and recommended that it be emptied more frequently. Mr. Paul Nice informed everyone that the dumpsters are emptied on Monday and Thursday afternoons. Mr. David Myers recommended the Material Resource Center on Schoolhouse Road for additional cardboard recycling sites.

Mr. Norman Hartzell questioned the board for a time frame on reporting back in regards to the Act 537 Plan meeting held at Hopewell Christian Fellowship. Manager Hammer replied that the township is still collecting feedback and completed questionnaires from the residents. Mr. Andrew Wakefield and his wife Ms. Diane Wakefield, of Gerhart Lane, raised concerns about a time frame in which they would be notified of a decision. They feel that the Board of Supervisors needs to provide direction as to if this will be a one year plan or a two year plan. Residents need to find ways to secure enough money in order to hook up to the public sewer lines that may be offered. Chairman Godshall stated that this is complicated issue that will be weighed heavily to try and meet the needs of the residents but no decisions have been made at this time. Solicitor Bartle informed the residents that there will another public meeting. That the Board of supervisors is required to hold an open meeting in order to vote on any issues. During this meeting there will be a portion open to public comment.

Mr. Rossino submitted the report and provided a summary of the projects. He also reported that the NPDES progress report was sent to DEP for review.

TREASURER'S REPORT -

Mr. Nice reported that a repayment of the TAN Note was made this month in the amount of \$250,000. Supervisor Nice made a motion to approve the Treasurer's report as presented, it was seconded by Mr. Kratz, and to provide authorization for the Treasurer to pay all bills for the respective funds as presented on Voucher No. 16-20-06 dated June 20, 2016 in the amount of \$457,171.42. The motion carried unanimously.
