Solicitor's Report – Frank Bartle, Esquire

- a) Pennsylvania Turnpike Stormwater Management Waiver Requests Mr. Bartle explained the Pennsylvania Turnpike has asked for several waivers as part of their widening project. Mr. Douglas Rossino, from Gilmore and Associates discussed that these are standard waivers and should not have any affect upon the township. Mr. Bartle asked for a motion to authorize advertisement. Supervisor Fazio motioned and Supervisor Barndt seconded the motion. Approved 5-0
- b) Resolution 16-05-21-03 A RESOLUTION OF THE GOVERNING BOARD OF CLIENT, COUNTY, PENNSYLVANIA, AUTHORIZING, EMPOWERING AND DIRECTING THE PROPER OFFICERS OF THE GOVERNING BOARD TO APPOINT A LIAISON BETWEEN IT AND BERKHEIMER, THE DULY APPOINTED COLLECTOR OF LOCAL TAXES FOR THE DISTRICT, FOR THE EXPRESS PURPOSE OF SHARING CONFIDENTIAL TAX INFORMATION WITH THE DISTRICT FOR OFFICIAL PURPOSES.
